DT Group expands by acquiring two stores for the STARK Chain

DT Group announces the acquisition of Ledreborg Tømmerhandel A/S. In future, this company's two stores in the Roskilde area will be outlets in the nationwide STARK Chain.

From 1 May, Ledreborg Tømmerhandel will be part of the STARK Chain. Bjørn Dahl, the owner of Ledreborg Tømmerhandel, which recently celebrated its 75th anniversary, has chosen to sell the family-owned builders' merchant business. The company's two stores on Ringstedgade and in Osted will continue operations with the same management and employees.

Ledreborg Tømmerhandel has 72 employees and annual revenues of DKK 150 million. The business was started up in 1931 by Bjørn Dahl's paternal grandfather, Harald Dahl, in collaboration with Count Holstein-Ledreborg, and has until now been operated by three generations of the Dahl family.

Ledreborg Tømmerhandel will be part of STARK, a nationwide chain of builders' merchants owned by the DT Group, the largest retailer and distributor of building materials in the Nordic region. STARK holds a market-leading position in Denmark and is already represented in the Roskilde area by STARK Bønnelycke. The acquisition of Ledreborg Tømmerhandel expands the STARK Chain to 80 stores, which sell building materials to a broad customer group ranging from professional builders and private DIY builders to ordinary consumer DIYers. In addition, the chain has minor sales to retailers and the wood-processing industry.
